Preliminary State Environmental Policy Act (SEPA) Determination:

A Mitigated Determination of Nonsignificance (MDNS) was previously issued on June 10, 2015 for a preliminary subdivision application 14 03456. SEPA review will be performed to evaluate possible additional impacts. Based upon DCD's review of the SEPA Environmental Checklist and what DCD knows about the proposal at this time, DCD expects to issue a Revised Determination of Non-Significance (DNS) for this project. The county is using the optional DNS process, allowed by SEPA under WAC 197.11.355 in which this Notice of Application and the SEPA threshold determination are reviewed concurrently. This may be the only opportunity to comment on the environmental impacts of the project. If this application is approved, the staff decision will include conditions to mitigate any anticipated environmental impacts, regardless of whether an Environmental Impact Statement (EIS) is prepared. The threshold determination will be mailed to all parties that

request a copy; copies are also available by written request to DCD, Attention: Clerk of the Hearing Examiner and Planning Commission.

The SEPA comment period is 14 days from the issuance of this notice. SEPA appeals are heard before the Hearing Examiner at a public hearing.

Type of Application: Site Development Activity Permit - Commercial

Description of Proposed Project: Residential Development of 103 Dwelling Units consisting of a mix of single-family dwellings and duplexes, ranging in size from 2000 square feet to 3700 square feet. The project was originally designed as a subdivided residential plat. Preliminary Plat approval was obtained under the previous owners, under Hearing Examiner's Decision 14 03456 dated July 17, 2015. The current project proposes to rescind the preliminary plat and instead of creating a residential subdivision will create senior housing residential cottages under one owner. A community center, pedestrian pathways, parking, public sewer, water, and stormwater facilities will also be provided.


